ELIGIBILITY

This competition is open to all artists now residing in Northern California, and all WASCO members. Paintings must be in watercolor or water media on paper (no canvas). The entry must be an original work, not more than two years old, and signed on the front. If collage material is used, it must have been painted in watercolor or water media by the artist. Entries may not have been accepted into any previous WASCO Aqua Areas shows.

AWARDS

Anticipated cash awards of over \$3,000 plus merchandise.

SLIDE ENTRY INFORMATION

Entries must be made by slides, 35 mm, 2x2" and mounted in paper or plastic (no glass). Each artist may submit up to three (3) entries. A non-refundable registration fee of sixteen dollars (\$16) per slide will be charged (\$13 per slide for fully active WASCO members). Mail slides, entry forms and long, self-addressed, stamped return envelope to Watercolor Artists of Sonoma County (WASCO), PO Box 269, Windsor, CA 95492. Accepted slides may be used for promotional purposes. **Slides will be returned to the artist.** Awards will be chosen by the judge after the paintings have been received. Any painting found to contain unacceptable materials, unsigned, or not identical to the slide submitted will be returned and WASCO reserves the right to withhold the hanging of any such work.

Watercolor Exhibition

FRAMING

Paintings must be framed with wood or metal under glass or plexiglass, with white or off-white mats (no exceptions) and must have wire on the back. Maximum size 45 inches in any direction and maximum weight of 25 pounds. Paintings must be identified on back with artist's name, phone number and title of the painting.

DELIVERY OF ACCEPTED WORKS

Paintings must be hand delivered on September 11, 2009. Artists whose paintings have been accepted for the exhibition will be sent further instructions regarding delivery of works.

RETURN OF WORK

All work must be picked up between 5:30 and 6:00 PM on Sunday, September 20 with no exceptions. No work will be released before this time. Artists will be charged \$5 per day per painting for late pick-up/storage.

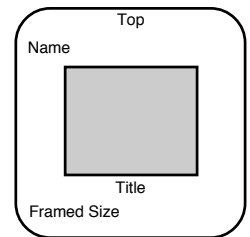
SALES

A commission of 30% will be retained by WASCO on all work sold during the exhibition. Tax will be added to the price of the painting. **All work must remain available for sale and display during the show.** Works may be designated not for sale (NFS) but only at time of entry of this form. Any artist who does not comply will be refused entry into future Aqua Area shows.

LIABILITY

By submission of any work, the artist agrees to abide by the exhibition rules and waives any and all claims against the Watercolor Artists of Sonoma County, Coddington Mall and/or any individual associated with the exhibition. Artists should carry their own insurance.

SLIDES

Slides must bear the name of the artist, title and framed size. Indicate top of painting on the front of the slide (which is the side that faces you when held up to a light to be viewed).
